An in-person board meeting held at the Pine Cove Water District conference room

There were 16 persons, including three guests attending.

Minutes – Sherry Edwards moved that the minutes be approved. Mark Dean seconded. Motion passed.

<u>Treasurer's Report</u>—Sherry Edwards. Sherry reported that the September beginning balance was \$8,122.02 The ending balance was \$5923.31. There were checks for the picnic expenses totaling \$2,461.71 and deposits of \$240.00 October beginning balance was \$5923.31. Ending balance was \$4,602.71. \$40.00 in deposits and \$1,360.60 in debits, mostly picnic expenses, but also bulk mailing permit and reimbursement to Richard Schwartz for some expenses. Motion to accept by Carolyn Levitski, seconded by Mark Dean. Motion carried.

<u>Membership</u>—Pat Hacker reported that currently there are 608 members for 2022. Membership applications for 2023 are starting to come in. Pat and Monica will monitor the email RSVPs for the Holiday Pot Luck. Monica suggested that we start a Facebook page and said she could make one.

<u>Roads and Traffic</u>—Richard Schwartz has relinquished representing PCPOA by cleaning the section of Hwy 243 for the Adopt a Highway program.

<u>Public Relations</u>—Mark Dean announced that Jon King has placed our logo on his web site, and thanks us for the donation. Sherry suggested flyers be prepared announcing the Holiday Pot Luck to be posted around town. Mark will make a draft flyer.
